THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) No 141/2000 of the European Parliament and of the Council of 16 December 1999 on orphan medicinal products¹, and in particular the first sentence of Article 5(8) thereof,

Having regard to the application submitted by Centro de Investigación Biomédica en Red (CIBER) on 24 June 2016 under Article 5(1) of Regulation (EC) No 141/2000,

Having regard to the favourable opinion of the European Medicines Agency, drawn up on 13 September 2016 by the Committee for Orphan Medicinal Products and received by the Commission on 20 September 2016,

Whereas:

- (1) The application submitted by Centro de Investigación Biomédica en Red (CIBER) concerning the medicinal product "Ubiquinol" was validated on 18 July 2016 under Article 5(4) of Regulation (EC) No 141/2000.
- (2) "Ubiquinol" meets the designation criteria referred to in Article 3(1) of Regulation (EC) No 141/2000.
- (3) The application should therefore be accepted,

HAS ADOPTED THIS DECISION:

Article 1

The medicinal product "Ubiquinol" is designated as an orphan medicinal product for the indication: Treatment of primary coenzyme Q₁₀ deficiency syndrome. It shall be entered in the Community Register of Orphan Medicinal Products under number EU/3/16/1765.

Article 2

The European Medicines Agency shall make available to all interested parties the opinion of the Committee on Orphan Medicinal Products referred to in this Decision.
